The company is disclosing information explaining the difference in after-tax profit that decreased compared to the same period last year in the Q4 2025 financial report as follows:

The company's after-tax profit in 2025 decreased compared to 2024 due to the following main reasons:

In 2025, the stock market experienced significant volatility, with reduced trading volume and lower stock prices compared to the previous year, leading to a sharp decline in revenue from proprietary trading activities. Although the



company managed to reduce some financial expenses and administrative expenses during the period, business results still declined significantly. These are the main reasons for the substantial decrease in business results in 2025 compared to 2024.
